



## RULES OF GOVERNANCE

The Inaugural Juneteenth Celebration, March & Festival is a community event for families and children. Its sole purpose is to celebrate the emancipation and pay tribute to freedom. This event will provide entertainment and recreation for our community. It is not a vehicle or platform to be used by individuals, groups, organizations or companies to demonstrate their political, social or other views or is it a means by which behavior; opinions and/or lifestyles inappropriate for children are to be displayed.

As a participant, you agree to be photographed, videotaped and grant the Elite News and the Blair Foundation permission to put the finished footage/photography to any uses that it may deem proper including marketing, advertising (print, radio and television) and PR related activities. You hereby release, discharge and agree to save harmless the Elite News and the Blair Foundation, its affiliates, employees, officers, and directors from any liability or claimed liability in connection with aforementioned use of your photograph, name, likeness or performance, including but not limited, any claim you have or might have for invasion of privacy, misappropriation and/or defamation.

1. Elite News & the Blair Foundation ("**EN / TBF**") reserves the right to deny permission to participate in the Juneteenth Celebration, March & Festival and (all) related activities to any individual, group, company or organization that does not fully comply with these Rules of Governance.
2. Any individual, group, company and organization permitted to participate in the Juneteenth Celebration, March & Festival agrees to abide by all rules and regulations now or hereafter promulgated by Elite News & the Blair Foundation. Failure to comply by an individual, group, company or organization will result in denial of participation in the march, festival and related activities. **EN / TBF** will have the sole right to determine any participant's failure to comply with these Rules of Governance.
3. **EN / TBF** have the right to approve or disapprove the wording of any sign carried or otherwise displayed in the Juneteenth Celebration, March & Festival and (all) related activities.
4. **EN / TBF** reserve the rights to limit the number of marchers in the parade on behalf of any particular participant.
5. **EN / TBF** reserve the right to approve uniforms, costumes or other clothing worn by individuals, companies, groups or members of any organization participating in the Juneteenth Celebration, March & Festival and (all) related activities.
6. **EN / TBF** reserve the right to approve messages, audio, verbal, musical or video used by participants in the Juneteenth Celebration, March & Festival and related activities.
7. Each participating individual, group, company or members of any participating organization will comply with all applicable federal, state and local laws and ordinances at all times in connection with the Juneteenth Celebration, March & Festival and (all) related activities.
8. The foregoing rules prescribe the terms of participation in the Juneteenth Celebration, March & Festival and (all) related activities. All participants must adhere to the above Rules of Governance, and any other rules or regulations promulgated by Elite News & the Blair Foundation at any time.
